# **GENERAL MANAGER'S REPORT**

A. Matters Affecting the District

General Manager Patrick McGowan reported that he would like to congratulate Mr. Palmer McCoy on his appointment to the Mercy Springs Board of Directors. Mr. McGowan also reported that he is actively looking at consolidating Mercy Springs Water District into Panoche Water District to help minimize costs and make things easier for everyone involved. In the meantime, we are going to look at our by-laws and see if we can revise our quorum to consist of 2 out of 3 Directors present. Mr. Mc Gowan also reported that at the beginning of July, Mercy Springs WD received word from the County of Fresno Grand Jury that they are conducting audits on the websites of special districts and that Mercy Springs Water District (MSWD) is one of them. Legal Counsel Gabriel Delgado indicated that MSWD is in compliance, while Mr. McGowan noted that the District has up to 90 days to complete the "District Transparency Certificate of Excellence" checklist. Mr. McGowan also discussed the permanent re-assignment to Angiola Water District and that this would be something he would be looking into.

Mr. McGowan reported that he has received an outline from Baker Manock Jensen of points to follow for potential consolidation.
